It is important that your grant is used effectively and based on school need. The [Education Inspection Framework](#) (Ofsted 2019 p64) makes clear there will be a focus on **‘whether leaders and those responsible for governors all understand their respective roles and perform these in a way that enhances the effectiveness of the school’**.

Under the [Quality of Education criteria](#) (p41) inspectors consider the extent to which schools can articulate their curriculum (INTENT), construct their curriculum (IMPLEMENTATION) and demonstrate the outcomes which result (IMPACT).

<p>Silver package from Activ8 has been brought in. Experts are working across KS1 and KS2 to improve pupil performance as well as increasing the confidence of staff to teach high quality sport and PE.</p> <p>Equipment to enable more active playtimes was purchased and used effectively in KS1 &amp; KS2.</p> <p>Staff have access to 'your-PE' website which gives comprehensive schemes of work and detailed lesson plans in all areas of PE.</p> <p>A new surface was put down underneath the KS1 trim trail.</p> <p>All staff met to discuss ensuring active classrooms throughout the school day and school invested in the iMoves platform to support staff in this.</p>	<p>Provision of after school clubs to promote a variety of sports and a healthy life style. Due to Covid, no clubs have been running this year. Activ8 have attended for lunchtimes and worked with different bubbles on different days so far, but this provision needs to be extended in the new school year, if restrictions allow.</p> <p>Improvements need to be made to the KS2 trim trail to ensure accessibility and safety for all.</p> <p>Due to Covid restrictions, opportunities for sporting competitions and events have been very limited.
